

LIMITED SUMMER SCHOOL TRANSPORTATION OFFERED BY LAMERS BUS LINES INC.

Lamers Bus Lines is offering limited school bus transportation for Summer School. Bus transportation is contracted between Lamers Bus Lines Inc. and the Parents/Guardians of the children utilizing the service. The Howard/Suamico School District has no involvement with the transportation offered.

Session I at Bay Port: June 15 – July 2, 2020, no school July 3 (14 days)

Session II at Bay Port: July 6 - July 24, 2020 (15 days)

- Arrival is at 7:55am and departure is at 12:35 pm. No alternate bus times.

Cost per child for each three week session is as follows:

- Before and after school transportation: \$97.40 for first child \$65.55 for each additional child in family.
- One-way transportation (either to or from school) \$59.43 for first child \$39.85 for each additional child in family.

Kindergarten Class to Forest Glen: June 22 – July 2, 2020, or July 13 - July 24, 2020

- Transportation to Forest Glen is for 7:40 a.m. arrival ONLY.
- No departure from Forest Glen. Parents will need to arrange for pick up from Forest Glen at 11:15 am.

Cost per child for the two-week session is as follows:

- Transportation to school only: \$40.50
- Registration & Payment must be made before May 22, 2020 to guarantee transportation for Session I
- Registration & Payment must be made before June 12, 2020 to guarantee transportation for Session II.
- No special prices will be made for special requests.
- No refunds will be issued.

2020 Summer School Transportation Rules and Consequences

We at Lamers Bus Lines reserve the right to terminate transportation to any student that may be a safety issue or disturbance in any way to other passengers or the driver. We expect all students to follow the bus rules listed below. If a student should not follow these rules; we will take the following actions. (Listed under consequences)

Bus Rules

1. No disobedient conduct toward the driver and other passengers
2. Stay seated in your seat – keep the aisle clear
3. Keep hands, feet, and objects to yourself and inside the bus
4. No shoving, fighting, swearing or loud talking anytime
5. No eating or drinking

Consequences

- 1st Violation: Lamers Bus Lines will send a letter home to parents, requesting the parents to call within 3 days of receiving the letter. The child will then be placed in a seat closer to the front for 5 days.
- 2nd Violation: Lamers Bus Lines will contact the parents and will inform them of their child's bus suspension for 3 full days without reimbursement.
- Severe Clause: If violation is serious or jeopardizes the safety of the passengers or driver. (For example: physical assault, verbal assault, use of illegal substance, weapons or fire causing agent) Lamers Bus Lines will contact the Parent(s) and the child(s) bus riding privileges will be suspended indefinitely.
 - There will not be a reimbursement for the unused portion of riding days that have been paid for
